I. Call to Order, Gerald Corkin, Chair

The Meeting was called to order by board chair Commissioner Corkin at approximately 2:01pm.

Voucher review — Questions Great Lakes entry on check register: Commissioner Corkin asked if it was for GoingPro training. CEO Raymond and CFO Viau indicate that it was from the FY19 funding, as we are able to expend it through Sept 2020. Commissioner Corkin is interested in how many people are trained for \$40K. Also, Commissioner Nykanen asked about a vehicle purchase that was paid for eligible supportive services for a



PATH participant, to remove a transportation barrier. The Mileage was a TAA policy approved expenditure.

Commissioner Corkin makes the motion to approve. The motion is supported by Commissioner Nykanen. Motion passed unanimously. CEO Raymond adds that as far as this report goes, the finances look pretty good. The GoingPro funding was eliminated by the state.

A couple of funds over the last few months were underspent, but we are catching up to. Commissioner Bonovetz asks if there have been any calls about not being able to reach Michigan Works! Commissioner Corkin reported that he had a few calls early on, trying to get in touch with UIA. We have been assisting UIA as much as possible.

Discussion on budget:

Board Chair Commissioner Corkin makes motion to pass budget resolution; Motion is supported by Commissioner Nykanen. The motion for Resolution is passes unanimously.

CEO Raymond updates that other services charges are down about 1.5 million. Michelle Viau, CFO explains that the personal services category includes some, but not all of our salary and fringes, because the Other services category also includes salary and costs, as well, as infrastructure, any specific programs, and the elimination of the GoingPro reduced the budget. CEO Raymond says it will primarily impact the GoingPro program/training for 2020/2021, but it does not affect UPMW operations. From an operational perspective, things are still fine. Commissioner Bonovetz informs the board that they have a MAC meeting tomorrow to adopt preliminary platforms. MAC is insisting that the state continue to fund the GoingPro program. They are sending that to the State, to say that GoingPro is a necessary expenditure. Commissioner Corkin adds that unless there is funding from the Federal level, there will be local impacts. Bill announces that the Governor just appointed a State Workforce board to focus on the MI Reconnect Program, and GoingPro. Tony Retaskie is our U.P. representative.

A. Chairman

Chairman Commissioner Gerry Corkin reports that Marquette County is working on the launch initiative. The vertical launch is supposed to be announced later this month. They are hoping for the best. Marquette county finished 4 of their labor agreements over a 3-yr period. Happy to get those behind them.

B. CEO

CEO Raymond talks about some of the task forces groups that have been set up at the State level and board members can sign up for those if they like. Bill has received feedback about how Michigan Works! has been helping to work with UIA to assist. It was reported that at one office in the U.P. we took over 300 calls, including assisting with calls from downstate. Commissioner Corkin asks if we have identified a rep from Marquette for the Community Corrections board – CEO Raymond to get back to Commissioner Corkin on who that is.

A Motion to accept report was made by Commissioner Bonovetz and supported by Commissioner Reiter. The motion passed.
