A. Action Items – Recommended Motions

1. PI 20-32 – AY 2020 Clean Slate Pilot Program

 - 1. Commissioner Phyllis French replaces Kevin Erickson Luce County
 - 2. Commissioner Scott Shackleton replaces Don McLean from Chippewa county. He will be assisted by Commissioner Jim Martin.
- Cabinet position on Rural Prosperity there has been a lot of interest in U.P. and lower Northern Michigan to have this position and they will be pursuing that with the governor.
- Childcare needs very interested in pursuing that, along with MEDC
- Familiarization Tour with MEDC, UP CDC, and local EDOs to get the benefit and awareness of the U.P. This was canceled in 2020 and hope to have in Aug 2021.
