VIII. Reports

A. Chairman

Chairman Commissioner Corkin shares that Chippewa county was picked to be control center for the spaceport project. The Commissioner says that this is good news for the U.P. If all approvals are granted over the next few years, 2023 will be the date for the operation center in Chippewa. 2025 would be for the launch in Marquette. It will be exciting to get the funding and approvals will mean a lot of good jobs in the U.P.

B. CEO

CEO Raymond goes into further detail about the CEO report. Commissioner Stevens had a few questions. Commissioner Stevens references the \$15/hour minimum wage increase. He wonders how that will be dealt with the in the future, from a UPMW perspective. CEO Raymond indicates that with the current stimulus, it appears there will be an extra \$300 stimulus for unemployment, which is half than the first stimulus and we will have to see how that works out with workers behavior and jobs outlook. He indicates that he has not heard much about it affecting whether workers want to go back to work or not. Commissioner Stevens asked if there were any other industries that they are worried about it. CEO Raymond indicates no; he has not heard about any specific industry concerns. Chair Corkin indicates that he understands and fully supports people working full-time. He comments that several of the states across the country have already done it (raised minimum wage to \$15) with little negative impact. Bill Raymond indicates he will keep the board informed on this topic.
