T.E.A.C.H. Early Childhood® Michigan, the Great Start to Quality Upper Peninsula Resource Center, the Great Start to Quality Northeast Resource Center, and Bay Mills Community College are partnering to bring high quality CDA training to meet the needs of early care and education providers in Michigan.

Bay Mills Community College ECE Courses Offer:

- **Online course format with virtual workshop sessions meeting once per month.**
- **The 120 hours of training required by the Council for Professional Recognition while earning 11 college credits.**
 - EC 107 first semester
 - EC 108 and EC 117 second semester
- **11 Credits that will apply toward a Child Development associate degree.**

T.E.A.C.H. Early Childhood® Michigan scholarships are available to cover most or all of the cost for college credits, books and the CDA credential fee for eligible participants. ECE classes and workshops are on a rotating schedule.
